

This complaint came up for final hearing before this Forum through video conferencing on 08.04.2025 in the presence of the respondents, complainant remained absent and having considered the material placed by both the parties, this Forum passed the following

**ORDER**

- 01.** The complainant filed the complaint during the Vidyut Adalat conducted on 22.01.2025 at Palamaner stating that his father applied for agriculture service connection about two years back but so far not released.





02. The said complaint was registered as C.G.No.264/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that the previous application of the complainant was deleted due to not showing the borewell and hence they advised the complainant to register new application.

03. Heard the respondents through video conferencing. Complainant remained absent. The respondents submit that the previous application of the complainant was deleted due to not showing the borewell and hence they advised the complainant to register new application. They further stated that recently the complainant registered the application, they prepared the estimations and the complainant paid the same and as per the priority they released the service connection. Recording the statement of the respondents, the respondents are directed to release the service connection as per the priority list. Accordingly, the complaint is closed. 


