
**ORDER**

01. The complainant filed the complaint during the Vidyut Adalat conducted on 22.01.2025 at Palamaner stating that they have consumed more power for six months on their service connection SC No.5821223000490 but now they are using only 40 HP and requested the respondents to inspect his premises and delete the additional load, but in vain.




02. The said complaint was registered as C.G.No.265/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that on receiving the complaint the respondent No.3 inspected the premises and found that there is no additional load and as such they have withdrawn the additional load demand notice.
03. Heard the respondents through video conferencing. Complainant remained absent. The respondents submit that on receiving the complaint, the respondent No.3 inspected the premises and found that there is no additional load and as such they have withdrawn the additional load demand notice. Since the grievance of the complainant is redressed, the complaint is closed. There is no order as to costs. The secretary of the Forum is instructed to forward a copy of this order to the complainant herein through whatsapp and Post.
04. The complainant is informed that if he is aggrieved by the order of the Forum, he may approach the Vidyut Ombudsman, 3<sup>rd</sup> Floor, Plot.
