

This complaint came up for final hearing before this Forum through video conferencing on 03.12.2024 in the presence of the complainant and respondents, and having considered the material placed by both the parties, this Forum passed the following


ORDER

- 01.** The complainant filed the complaint during the Vidyut Adalat conducted on 04.07.2024 at Paipalli stating that they are residing in Diguvamaredupalli (V) in which they are facing frequent low voltage problem in the night time.




02. The said complaint was registered as C.G.No.71/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that subsequent to the complaint, they replaced the electric line with new cable and resolved the low voltage issue.
03. Heard complainant and respondents through video conferencing. The respondents submit that subsequent to the complaint, they replaced the old electric line with new cable and resolved the low voltage issue which is admitted by the complainant. Since the grievance of the complainant is redressed, the complaint is closed. There is no order as to costs.
04. The complainant is informed that if he is aggrieved by the order of the Forum, he may approach the Vidyut Ombudsman, 3rd Floor, Plot. No.38, Adjacent to Kesineni Admin Office, Sriramachandra Nagar, Mahanadu Road, Vijayawada-08 in terms of Clause.13 of Regulation.No.3 of 2016 of Hon'ble APERC within 30 days from the date of receipt of this order and the prescribed format is available in the website vidyutombudsman.ap.gov.in.
