
ORDER

01. The complainant filed the complaint during Vidyut Adalat conducted at Pulivendula on 05.07.2024 stating that the respondents erected




electric pole in his site causing obstruction for construction of his house.


02. The said complaint was registered as C.G.No.82/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that for shifting of the electric pole, the complainant has to register an application in mee-seva but the complainant did not register any application.
03. Heard both the parties through video conferencing. The complainant admitted that he has not register any application in mee-seva as per rules in vogue. The respondents submit that soon after registration of the application by the complainant, they will initiate necessary action for shifting of the pole. Hence, the complainant is advised to register an application for shifting of pole in mee-seva on which the respondents are directed to take necessary action. Accordingly, the complaint is closed. There is no order as to costs.
04. The complainant is informed that if he is aggrieved by the order of the Forum, he may approach the Vidyut Ombudsman, 3rd Floor, Plot. No.38, Adjacent to Kesineni Admin Office, Sriramachandra Nagar, Mahanadu Road, Vijayawada-08 in terms of Clause.13 of Regulation.No.3 of 2016 of Hon'ble APERC within 30 days from the





date of receipt of this order and the prescribed format is available in the website vidyutombudsman.ap.gov.in.
