
This complaint came up for final hearing before this Forum through video conferencing on 05.08.2024 in the presence of the respondents, complainant remained absent and having considered the material placed by both the parties, this Forum passed the following

ORDER

- 01.** The complainant filed the complaint during Vidyut Adalat conducted at Puivendula on 05.07.2024 stating that 33 KV line is passing on their house endangering human lives and it is to be shifted.




- 02.** The said complaint was registered as C.G.No.84/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that for shifting of the 33 KV electric line, the complainant has to register an application in mee-seva but the complainant did not register any application.
- 03.** Heard respondents through video conferencing. The complainant remained absent. It seems that the complainant has not registered an application in mee-seva following the rules in vogue to initiate action by the respondents for shifting the 33 KV electric line. The respondents submit that soon after registration of the application by the complainant, they will initiate necessary action for shifting of the electric line. Hence, the complainant is advised to register an application for shifting of electric line in mee-seva on which the respondents are directed to take necessary action. Accordingly, the complaint is closed. There is no order as to costs.
- 04.** The complainant is informed that if he is aggrieved by the order of the Forum, he may approach the Vidyut Ombudsman, 3rd Floor, Plot. No.38, Adjacent to Kesineni Admin Office, Sriramachandra Nagar, Mahanadu Road, Vijayawada-08 in terms of Clause.13 of Regulation.No.3 of 2016 of Hon'ble APERC within 30 days from the





