


This complaint came up for final hearing before this Forum through video conferencing on 22.10.2024 in the presence of the complainant and respondents and having considered the material placed by both the parties, this Forum passed the following

ORDER

01. The complainant filed the complaint during the Vidyut Adalat conducted on 04.09.2024 at Badvel stating that he applied for shifting of his Agricultural service connection ASC.No.2622444000305 by paying necessary shifting charges but the respondents did not take any action.



02. The said complaint was registered as C.G.No.121/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that subsequent to the complaint, the complainant changed his mind and requested them not to shift the transformer and he is going to withdraw the complaint filed before this Forum.
03. Heard complainant and respondents through video conferencing. The complainant during the enquiry submitted that he is withdrawing his complaint and there is no need for shifting of the transformer. He also gave a letter to that effect to the respondents and a copy of the same is submitted before us. The complainant admitted that the original of the said letter was given by him to the respondents requesting not to shift the transformer and he is withdrawing the complaint. The complaint is dismissed as withdrawn. There is no order as to costs.
04. The complainant is informed that if he is aggrieved by the order of the Forum, he may approach the Vidyut Ombudsman, 3rd Floor, Plot. No.38, Adjacent to Kesineni Admin Office, Sriramachandra Nagar, Mahanadu Road, Vijayawada-08 in terms of Clause.13 of Regulation.No.3 of 2016 of Hon'ble APERC within 30 days from the



date of receipt of this order and the prescribed format is available in the website vidyutombudsman.ap.gov.in.
