The respondents submitted their response stating that the Village Revenue officer and the housing department officials asked them not to issue the service connection to the complainant since the complainant constructed his house occupying the public road and hence they asked the complainant to bring no objection certificate from the concerned to issue the service connection but the complainant did not submit the same.
- Heard complainant and respondents through video conferencing. The respondents submit that the housing board officials and the VRO informed them that the complainant constructed the house encroaching the public road and asked them not to issue the service connection and hence they asked the complainant to bring NOC from the concerned to release the service connection. The complainant during the enquiry submitted that he would obtain NOC from the concerned and submit the same to the respondents and further requested to permit him to withdraw the complaint.
