**02.** The said complaint was registered as C.G.No.221/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that on receiving the complaint, they replaced the damged electric pole.

O3. Heard the respondents through video conferencing. Complainant remained absent. The respondents submit that they replaced the damaged electric pole. The complainant issued letter of satisfaction stating that the damaged pole is replaced. Since the purpose is served, the complaint is closed. There is no order as to costs.
