
**ORDER**


- 01.** The complainant filed the complaint during the Vidyut Adalat conducted on 06.12.2024 at Jammalamadugu stating that one electric pole is erected adjacent to his house compound wall and it is now damaged and hence to be replaced.

02. The said complaint was registered as C.G.No.221/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that on receiving the complaint, they replaced the damaged electric pole.
03. Heard the respondents through video conferencing. Complainant remained absent. The respondents submit that they replaced the damaged electric pole. The complainant issued letter of satisfaction stating that the damaged pole is replaced. Since the purpose is served, the complaint is closed. There is no order as to costs.
04. The complainant is informed that if he is aggrieved by the order of the Forum, he may approach the Vidyut Ombudsman, 3<sup>rd</sup> Floor, Plot. No.38, Adjacent to Kesineni Admin Office, Sriramachandra Nagar, Mahanadu Road, Vijayawada-08 in terms of Clause.13 of Regulation.No.3 of 2016 of Hon'ble APERC within 30 days from the date of receipt of this order and the prescribed format is available in the website vidyutombudsman.ap.gov.in.
