ORDER

on 24.01.2025 at Kadapa stating that there is necessity to effect changes in the alignment of 33 KV line passing from Balajinagar to Mulavanka and inspite the his requests, there was no response form the respondents.

- were issued to the respondents calling for their response. The respondents submitted their response stating that the old 33 KV line is very much essential to provide alternate supply in case of failure of new 33 KV line due to breakdown or any failure and as such there is no possibility to dismantle the old existing 33 KV line and there is no scope for effect changes in the alignment of new 33 KV line.
- o3. Heard the respondents through video conferencing. Complainant remained absent. The respondents submit that the old 33 KV line is very much essential to provide alternate supply in case of failure of new 33 KV line due to breakdown or any failure and as such there is no possibility to dismantle the old existing 33 KV line and there is no scope for effect changes in the alignment of new 33 KV line. The complainant remained absent and failed to explain the necessity to change the alignment of new 33 KV line and dismantlement of the old 33 KV line. Hence, accepting the version of the respondents, we feel that there is no merit in the complaint. Accordingly, the complaint is dismissed. There is no order as to costs. The secretary of the Forum is instructed to forward a copy of this order to the complainant herein through whatsapp and Post.
