
ORDER



02. The said complaint was registered as C.G.No.353/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that on receiving the complaint they rectified the mistake.
03. Heard the respondents through video conferencing. Complainant remained absent. The respondents submit that on receiving the complaint, they rectified the mistake. We confirmed the same on verification in the website of APSPDCL. Since the grievance of the complainant is redressed, the complaint is closed. There is no order as to costs.
