The respondents submitted their response stating that subsequent to the complaint, they replaced the damaged pole with another pole in good condition and thereby resolved the grievance of the complainant.
- 03. Complainant absent. Heard the respondents through video conferencing.
- O4. Subsequent to filing of the complaint, the grievance of the complainant is resolved by the respondents. The complainant when we contacted her through phone, she reported that the respondents removed the damaged electric pole and erected a new pole and requested to close the complaint. Hence, this Forum opines that this complaint is to be closed as purpose served. Accordingly, the complaint is closed. No order as to costs.
