#### **ORDER**

**01.** The complainant filed the complaint during Vidyut Adalat conducted at Sullurpet on 21.06.2024 stating that at GNT Road, Sullurpet they



are facing low voltage problem and requested for rectification of the same.

- were issued to the respondents calling for their response. The respondents submitted their response stating that they inspected the premises of the complainant on 22.06.2024 and noticed that the house of the complainant is located at tail end of the LT feeder from the existing DTR and to rectify the low voltage problem in the premises of the complainant, an additional DTR is to be erected and accordingly they prepared the estimate and obtained sanction and they would complete the work within a month.
- o3. Heard respondents through video conferencing. The complainant remained absent. The respondents erected an additional DTR and resolved the low voltage problem and they also submitted compliance report. The complainant issued letter of satisfaction reporting that an additional DTR was erected and their low voltage problem was solved and he also admitted that copy of the satisfaction letter produced by the respondents was issued by him and requested to close the complaint as the purpose is served. of the complainant is redressed, the complaint is closed, as the purpose is served. There is no order as to costs.
