<u>ORDER</u>

01. The complainant during the Vidyut Adalat conducted on 21.06.2024 at Sullurpet filed the complaint stating that LT line and poles were not

- erected to the water works service at Mangalampadu (V) in Sullurpet Rural section.
- o2. The said complaint was registered as C.G.No.43/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that subsequent to the complaint, they prepared the estimate for erection of LT line and RWS Department paid the necessary service line charges and they have completed the work on 09.07.2024.
- **03.** Complainant absent. Heard the respondents through video conferencing.
- When we contacted the complainant through phone, he reported that LT line and poles were erected to the water works service at Mangalampadu (V) and the respondents redressed their grievance. Subsequent to filing of the complaint, since the grievance of the complainant is resolved by the respondents and hence, this Forum opines that this complaint is to be closed as purpose is served. Accordingly, the complaint is closed. No order as to costs.
