
**ORDER**

01. The complainant during the Vidyut Adalat conducted on 08.07.2024 at Nellore filed the complaint stating that one LT/HT line is passing in the Sri Sri Sri Seetharamanjaneya Swamy temple Street, Nellore and the



electrical wires between the pole Nos. HP 72/A4 and A5 are hanging causing danger to the lives of the people passing through the street.

02. The said complaint was registered as C.G.No.88/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that subsequent to the complaint they erected one additional pole between the pole Nos. HP72/A4 and A5 and thereby resolved the issue.
03. Complainant absent. Heard the respondents through video conferencing.
04. Subsequent to filing of the complaint, the grievance of the complainant is resolved by the respondents. The respondents also produced copy of letter issued by the complainant expressing his satisfaction for resolving their grievance by the respondents. Hence, this Forum opine that this complaint is to be closed as the purpose is served. Accordingly, the complaint is closed. No order as to costs.
05. The complainant is informed that if he is aggrieved by the order of the Forum, he may approach the Hon'ble Vidyut Ombudsman, 3<sup>rd</sup> Floor, Plot.No.38, Adjacent to Kesineni Admin Office, Sriramachandra Nagar, Mahanadu Road, Vijayawada-08 in terms of Clause.13 of Regulation.No.3 of 2016 of Hon'ble APERC within 30 days from the date of receipt of this
