## **ORDER**

01. The complainant filed the complaint during the Vidyut Adalat conducted on 05.09.2024 at Kaligiri stating that in the ST Colony in Polampadu Village the existing DTR is overloaded and they are facing low voltage problem and erection of one additional DTR is required.

- **02.** The said complaint was registered as C.G.No.141/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that subsequent to the complaint, they erected additional 16 KVA single phase DTR and resolved the issue.
- **03.** Heard complainant and respondents through video conferencing. The respondents submit that subsequent to the complaint, they erected additional single phase 16 KVA DTR and resolved the issue which is admitted by the complainant. Since the grievance of the complainant is redressed, the complaint is closed. There is no order as to costs.
