This complaint came up for final hearing before this Forum through video conferencing on 19.12.2024 in the presence of the respondents, complainant remained absent and having considered the material placed by both the parties, this Forum passed the following

<u>ORDER</u>

01. The complainant filed the complaint during the Vidyut Adalat conducted on 04.10.2024 at Kaluvoya stating that one electric pole was erected

across the entrance gate of his house and he requested the respondents

to shift the same but in vain.

- **02.** The said complaint was registered as C.G.No.152/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that for shifting of the electric pole the complainant has to make an application and has to pay the shifting charges but in the case on hand the complainant did not make any application.
- 03. Heard respondents through video conferencing. Complainant remained absent. According to the respondents for shifting of the electric pole, the complainant has to make an application through mee-seva and has to pay the estimated shifting charges but in the case on hand the complainant has not made any application. The complainant fail to attend the enquiry and fail to rebut the version of the respondents. The complainant admittedly did not make any application for shifting of the electric pole. When the complainant did not make any application and did not pay the shifting charges, the respondents cannot be directed to shift the electric pole. is dismissed. However, if the Accordingly, this complait complainant apply for shifting of the pole and pay the estimated shifting charges, the respondents are directed to shift the electric pole without any delay by following the SOP norms. There is no order as to costs.
