The respondents submit that they are preparing the estimates and submit the same to the competent authority and on getting the sanction of the estimate, they would execute the work and in the mean while they have taken steps to resolve the low voltage problem in the village. The complainant did not attend the enquiry to deny the statement of the respondents. The respondents are directed to take steps for installation of another transformer according to the requirement for permanent solvation of low voltage problem as early as possible under intimation to the Forum. Accordingly, the complaint is closed. There is no order as to costs.
