This complaint came up for final hearing before this Forum through video conferencing on 21.02.2025 in the presence of the respondents, complainant remained absent and having considered the material placed by both the parties, this Forum passed the following

ORDER

01. The complainant filed the complaint during the Vidyut Adalat conducted on 04.10.2024 at Kaluvoya stating that electrical line is passing over their houses in Kulluru ST Colony and they are to be shifted.

- **02.** The said complaint was registered as C.G.No.173/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that on receiving the complaint, they issued notice to the complainant asking him to register an application for shifting of the line on which they prepare the estimates, but the complainant so far not registered any application.
- O3. Heard the respondents through video conferencing. Complainant remained absent. The respondents submit that on receiving the complaint, they issued notice to the complainant asking him to register an application for shifting of the line on which they prepare the estimates, but the complainant so far not registered any application. The complainant did not attend the enquiry. As per the rules in vogue, the complainant has to register an application for shifting of the line and to pay the shifting charges to the respondents. Here in the case on hand, the complainant did not register application so far. Hence, the complainant is directed to register an application in mee-seva and to pay the estimated charges for shifting of line on which the respondents are directed to take action. With the said direction, this complaint is closed. There is no order as to costs.
- **04.** The complainant is informed that if he is aggrieved by the order of the Forum, he may approach the Vidyut Ombudsman, 3rd Floor, Plot. No.38, Adjacent to Kesineni Admin Office, Sriramachandra Nagar, Mahanadu Road, Vijayawada-08 in terms of Clause.18.1 of Regulation.No.3 of 2016 of Hon'ble APERC within 30 days from the date of receipt of this order
