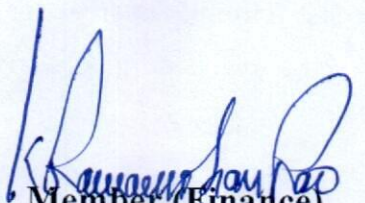
ORDER

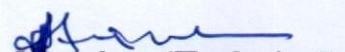
- 01.** The complainant filed the complaint stating that she applied for new service connection on 23.07.2024 for her house but it was not released till this date.
