



This complaint came up for final hearing before this Forum through video conferencing on 08.04.2025 in the presence of the complainant and respondents and having considered the material placed by both the parties, this Forum passed the following

ORDER

- 01.** The complainant filed the complaint during the Vidyut Adalat conducted on 05.12.2024 at Buchireddypalem stating that they are having plots in an extent of Ac.2.57 Cents in Sy.No.12/3 of Jandadibba Village and the same were occupied by the villagers raising thatched sheds, that the respondents erected 10 electric poles to supply electricity to the said thatched houses, that on 10.02.2022 the MRO and District surveyor conducted survey and identified the said plots belongs to the complainant and others and they requested the respondents to remove the service connections, but in vain. 

02. The said complaint was registered as C.G.No.214/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that the respondent No.2 inspected the disputed site and noticed that the layout is unauthorized without any approach roads and some of the villagers occupied the site claimed by the complainant and others and obtained service connections during the year 2020 and they asked the complainant to show the boundaries of their land to resolve their grievance.
03. Heard the complainant and respondents through video conferencing. Perused the entire record. Even according to the complainant, their sites are under occupation by third parties in which the encroachers made constructions and obtained electrical service connections. The third parties are not parties to this complaint. It is to be decided whether the third parties are encroachers of the site of the complainant and others and they are to be lawfully evicted. For that the complainant and others have to take steps before a competent Civil Court to get the lawful eviction of the encroachers from their site and that task cannot be taken up by this Forum. Until the encroachers are lawfully evicted, the respondents cannot be directed to disconnect the service connections since the same were issued long back in the year 2020. Hence, the complainant and others are advised to approach a Civil Court and to get lawful eviction of the encroachers from their site and then the respondents will certainly disconnect the service connections. We find no merit in the complaint. Accordingly, the complaint is dismissed. There is no order as to costs. The secretary of the Forum is instructed to forward a copy of this order to the complainant herein through whatsapp and Post.

04. The complainant is informed that if he is aggrieved by the order of the Forum, he may approach the Vidyut Ombudsman, 3rd Floor, Plot. No.38, Adjacent to Kesineni Admin Office, Sriramachandra Nagar, Mahanadu Road, Vijayawada-08 in terms of Clause.18.1 of Regulation.No.3 of 2016 of Hon'ble APERC within 30 days from the date of receipt of this order and the prescribed format is available in the website vidyutombudsman.ap.gov.in.
