
ORDER


- 01.** The complainant filed the complaint during the Vidyut Adalat conducted on 05.12.2024 at Buchireddypalem stating that they purchased plots in a layout at Rajupalem, Road, Buchireddypalem in which there are some electric poles in existence causing obstruction for construction of houses and the said electric poles are to be shifted.

02. The said complaint was registered as C.G.No.216/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that on receiving the complaint, they shifted the electric poles from the plots of the complainant and others and resolved the grievance of the complainant and others.
03. Heard the respondents through video conferencing. Complainant remained absent. The respondents submit that on receiving the complaint, they shifted the electric poles from the plots of the complainant and others and resolved the grievance of the complainant and others. When we contacted the complainant, he reported that the respondents completed shifting work of the poles to their satisfaction and requested to close the complaint. Since the grievance of the complainant is redressed, the complaint is closed. There is no order as to costs.
04. The complainant is informed that if he is aggrieved by the order of the Forum, he may approach the Vidyut Ombudsman, 3rd Floor, Plot. No.38, Adjacent to Kesineni Admin Office, Sriramachandra Nagar, Mahanadu Road, Vijayawada-08 in terms of Clause.18.1 of Regulation.No.3 of 2016 of Hon'ble APERC within 30 days from the date of receipt of this order and the prescribed format is available in the website vidyutombudsman.ap.gov.in.
