- 01.** The complainant filed the complaint during the Vidyut Adalat on 05.12.2024 at Buchireddypalem stating that in their land the Respondents erected 33 KV line and it is to be shifted.





02. The said complaint was registered as C.G.No.217/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that on receiving the complaint, they prepared the estimates for shifting of the line and on payment of the shifting charges by the complainant, they completed the shifting work on 25.03.2025 to the satisfaction of the complainant.
03. Heard the respondents through video conferencing. The complainant remained absent. The respondents submit that on receiving the complaint, they prepared the estimates for shifting of the line and on payment of the shifting charges by the complainant, they completed the shifting work on 25.03.2025 to the satisfaction of the complainant. The complainant issued letter of satisfaction confirming the shifting of the lines from his site. Since the grievance of the complainant is redressed, the complaint is closed.
