ORDER

o1. The complaint is filed during the Vidyut Adalat conducted on 11.02.2025 at Rapur stating that they are having agriculture service connections within the jurisdiction of Vepanapi Sub Station, that their fields and Vepanapi substation are intervened with a railway line and for supply of the power cable is run underneath the railway line and as the said cable was burnt power supply was stopped from Vepanapi sub station and now the supply is given to them from Marlapudi substation which is far away from their fields and thereby requested to replace the burnt cable and restore the power supply from Vepanapi substation.

C.G.NO. 283/2024-25/NELLORE CIRCLE

- were issued to the respondents calling for their response. The respondents submitted their response stating that for rectification of damaged 11 KV cable passing under crossing of railway line, necessary permissions from the railway authorities are required and they addressed a letter seeking for according permission and soon after getting the permissions they will undertake the rectification work of damaged cable.
- o3. Heard the respondents through video conferencing. Complainant remained absent. The respondents submit that for rectification of damaged 11 KV cable passing under crossing of railway line, necessary permissions from the railway authorities are required and they addressed a letter seeking for according permission and soon after getting the permissions they will undertake the rectification work of damaged cable. Considering the circumstances, the respondents are directed to complete the rectification work of the damaged cable on getting necessary permissions from the railway authorities and their higher officials. With the said direction, the complaint is closed. There is no order as to costs.
