This complaint came up for final hearing before this Forum through video conferencing on 22.10.2024 in the presence of the complainant and respondents and having considered the material placed by both the parties, this Forum passed the following

ORDER

01. The complainant filed the complaint during the Vidyut Adalat conducted on 08.08.2024 at Kuppam stating that they own land of Ac.2.37 Cents in Sy.No.13/1 in which the respondents erected one



service transformer with SC.No. 1614 which does not belong to them and they requested the respondents to shift the transformer from their land, but in vain.

02. The said complaint was registered as C.G.No.111/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that on 10.10.2024 one Sankarappa S/o. Ramappa got issued a legal notice stating that the complainant herein filed a suit OS.No.137/2021 against his client in which the complainant herein has admitted that in the land Sy.No.13/1 one bore well and electrical service connection which belongs to his client are available and now with regard to the said land bearing Sy.No.13/1 title dispute is pending before the Civil Court and requested the respondents not to shift the transformer and under those circumstances they could not consider the request of the complainant.

03. Heard both the parties through video conferencing. The complainant during the enquiry admitted that she filed suit OS.No.137/2021 against Sankarappa and another seeking for their eviction from the land in Sy.No.13/1 in which the bore well and service connection of Sankarappa are available and the said suit is pending for trial before



the Civil Court. Considering the circumstances, as title dispute is pending between the complainant and one Sankarappa in whose name the service connection relating to the land in Sy.No.13/1 is pending before a Civil Court, this Forum cannot order for shifting of the transformer and the complainant is advised to present his grievance and seek for appropriate relief in the pending suit before the Civil Court. With the said observation, the complaint is closed. There is no order as to costs.

04. The complainant is informed that if she is aggrieved by the order of the Forum, she may approach the Vidyut Ombudsman, 3rd Floor, Plot. No.38, Adjacent to Kesineni Admin Office, Sriramachandra Nagar, Mahanadu Road, Vijayawada-08 in terms of Clause.13 of Regulation.No.3 of 2016 of Hon'ble APERC within 30 days from the date of receipt of this order and the prescribed format is available in the website vidyutombudsman.ap.gov.in.
