
ORDER

- 01.** The complainant filed the complaint during Vidyut Adalat conducted at Kuppam on 08.08.2024 stating that they are having house site in Balla Village and ZP High School building is located on the back




side of their site and the electricity line of ZP High School is passing through their house site and causing obstruction for making any constructions in their house site and requested for shifting of the said line.

- 02.** The said complaint was registered as C.G.No.108/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that they have prepared an estimate and got it sanctioned for Rs.32,500/- towards shifting charges for the line and served the demand notice on the complainant on 19.08.2024 and on receipt of the payment of the shifting charges, they will shift the line.
- 03.** Heard respondents through video conferencing. The complainant is present. The respondents submit that the complainant paid the shifting charges and accordingly they have shifted the line and the complainant confirmed the same. Since the purpose of the complainant is served, the complaint is closed. There is no order as to costs.
- 04.** The complainant is informed that if he is aggrieved by the order of the Forum, he may approach the Vidyut Ombudsman, 3rd Floor, Plot. No.38, Adjacent to Kesineni Admin Office, Sriramachandra Nagar,







