one of the transformer.

The complainant filed the complaint stating that the respondents proposed to erect transformer on a pole in the public Road which causes obstruction to the way and inconvenience to the customers who visit their branch and the respondents did not consider their objection to the erection of the transformer.

- Were issued to the respondents calling for their response. The respondents submitted their response stating that they erected the transformer infront of the building of the consumer and it no way causes any obstruction to the visitors of the bank.
- o3. Heard the respondents through video conferencing. Complainant remained absent. The respondents submit that they erected the transformer infront of the building of the consumer and it no way causes any obstruction to the visitors of the bank. The respondents also filed a copy of the photograph showing the position of the transformer. The photograph shows that the transformer is fixed to the electric pole at a certain height from the ground level and the pole is erected infront of the shop of the consumer and it is not infront of the gate of the complainant's bank. We are of the opinion that the existing pole is not an obstruction to the visitors of the complainant's bank. Accordingly, the complaint is dismissed. There is no order as to costs. The secretary of the Forum is instructed to forward a copy of this order to the complainant herein through whatsapp and Post.
- **04.** The complainant is informed that if he is aggrieved by the order of the Forum, he may approach the Vidyut Ombudsman, 3rd Floor, Plot. No.38, Adjacent to Kesineni Admin Office, Sriramachandra Nagar,

Mahanadu Road, Vijayawada-08 in terms of Clause.18.1 of Regulation.No.3 of 2016 of Hon'ble APERC within 30 days from the date of receipt of this order and the prescribed format is available in the website vidyutombudsman.ap.gov.in.
