

ORDER

- 01.** The complainant filed the complaint during the Vidyut Adalat conducted on 25.02.2025 at Kadiri stating that he is having House SC.No:7411308000076 to which an agricultural SC.No: 7411308000092 belongs to another person is linked and it is to be de-linked.



02. The said complaint was registered as C.G.No.308/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that on receiving the complaint the agricultural service connection is de-linked with the house service connection of the complainant.
03. Heard the respondents through video conferencing. Complainant remained absent. The respondents submit that on receiving the complaint, the agricultural service connection is de-linked with the house service connection of the complainant. Since the grievance of the complainant is redressed, the complaint is closed. There is no order as to costs.
