This complaint came up for final hearing before this Forum through video conferencing on 03.07.2024 in the presence of the respondents and the complainant remained absent and having considered the complaint and submissions of both the parties, this Forum passed the following:

**ORDER**

- 01.** The complainant filed the complaint stating that the respondents erected an electrical pole in his site and he requested them for removal of the said pole but in vain.
- 02.** The said complaint was registered as C.G.No.01/2024-25 and notices were issued to the respondents calling for their response. The

respondents submitted their response stating that they requested the complainant for payment of shifting charges and on payment of the said charges, they would complete the work.

03. Heard respondents through video conferencing. The complainant remained absent. The respondents subsequent to the complaint, shifted the electric pole from the site of the complainant and the complainant admitted the same when we contacted him through phone and he requested to close the complaint as the purpose is served. Since the grievance of the complainant is redressed, this Forum feel that this complaint can be closed.
04. ***In the result***, the complaint is closed. There is no order as to costs.
05. The complainant is informed that if he is aggrieved by the order of the Forum, he may approach the Vidyut Ombudsman, 3<sup>rd</sup> Floor, Plot. No.38, Adjacent to Kesineni Admin Office, Sriramaachandra Nagar, Mahanadu Road, Vijayawada-08 in terms of Clause.13 of Regulation.No.3 of 2016 of Hon'ble APERC within 30 days from the date of receipt of this order and the prescribed format is available in the website vidyutombudsman.ap.gov.in.
