

This complaint came up for final hearing before this Forum through video conferencing on 05.05.2025 in the presence of the respondents, complainant remained absent and having considered the material placed by both the parties, this Forum passed the following

ORDER

- 01.** The complainant filed the complaint during the Vidyut Adalat conducted on 20.03.2025 at Kota stating that they are having agriculture Service SC No.1221 in the name of Late. Pokkalayya and it was dismantled and it is to be restored.



02. The said complaint was registered as C.G.No.342/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that the service under question is dismantled long back and the applicant is not related to late. Pokkalayya who died long back and hence it is not possible to restore the service in the name of the complainant.

03. Heard the respondents through video conferencing. Complainant remained absent. The respondents submit that the service under question is dismantled long back and the applicant is not related to late. Pokkalayya who died long back and hence it is not possible to restore the service in the name of the complainant. The complainant did not produce any documents to show how he is related to late. Pokkalayya except asking for restoration of service in his name. Hence, the complainant is not entitled for restoration of the service in his name. We find no merit in the complaint. 
04. The complainant is informed that if he is aggrieved by the order of the Forum, he may approach the Vidyut Ombudsman, 3rd Floor, Plot.


