This complaint came up for final hearing before this Forum through video conferencing on 05.08.2024 in the presence of the complainant and respondents and having considered the material placed by both the parties, this Forum passed the following.

ORDER

01. The complainant filed the complaint during the Vidyut Adalat conducted on 10.07.2024 at Piler stating that he is having an



- agricultural service connection and the transformer concerned was burnt and the same is to be replaced.
- 02.** The said complaint was registered as C.G.No.96/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that subsequent to the complaint, they have replaced the damaged transformer with a working transformer and resolved the grievance of the complainant. The respondents also submitted letter of satisfaction issued by the complainant.
- 03.** Heard both the parties through video conferencing. The respondents subsequent to the complaint, replaced the damaged transformer with transformer in working condition and the complainant also admitted the same and requested to close the complaint as purpose is served. Since the grievance of the complainant was redressed, this Forum feel that this complaint can be closed.
- 04.** *In the result*, the complaint is closed. There is no order as to costs.
- 05.** The complainant is informed that if he is aggrieved by the order of the Forum, he may approach the Vidyut Ombudsman, 3rd Floor, Plot. No.38, Adjacent to Kesineni Admin Office, Sriramachandra Nagar, Mahanadu Road, Vijayawada-08 in terms of Clause.13 of

Regulation.No.3 of 2016 of Hon'ble APERC within 30 days from the date of receipt of this order and the prescribed format is available in the website vidyutombudsman.ap.gov.in.
