This complaint came up for final hearing before this Forum through video conferencing on 03.09.2024 in the presence of the respondents, complainant remained absent and having considered the complaint and submissions of both the parties, this Forum passed the following:

ORDER

01. The complainant filed the complaint during the Vidyut Adalat conducted at Madanapalli on 20.06.2024 stating that he applied for



agricultural service connection, but the respondents did not allot DTR and did not release the service connection.

02. The said complaint was registered as C.G.No.45/2024-25 and notices were issued to the respondents calling for their response. The respondents submitted their response stating that they have drawn the DTR and other material from the District Stores and completed the work and released the service connection.

03. Complainant remained absent. Heard the respondents through video conferencing. Subsequent to the complaint, the respondents erected the DTR and released the service connection of the complainant and redressed the grievance of the complainant. The complainant when we contacted him through phone, reported that DTR was erected and the respondents released the service connection and requested to close the complaint. Since the grievance of the complainant is redressed, this complaint can be closed as purpose served.

04. ***In the result***, the complaint is closed. There is no order as to costs.

05. The complainant is informed that if he is aggrieved by the order of the Forum, he may approach the Vidyut Ombudsman, 3rd Floor, Plot. No.38, Adjacent to Kesineni Admin Office, Sriramachandra Nagar, Mahanadu Road, Vijayawada-08 in terms of Clause.13 of



Regulation.No.3 of 2016 of Hon'ble APERC within 30 days from the date of receipt of this order and the prescribed format is available in the website vidyutombudsman.ap.gov.in.
