ORDER

01. The complainant filed the complaint during the Vidyut Adalat conducted at Paipalli on 04.07.2024 stating that he is having agricultural service connection SC.No. 5633405000756 and about

six years back the DTR relating to his service connection was stolen by unknown culprits and the copy of the FIR was sent to the respondents by Irala police but till date DTR was not supplied by the respondents.

- were issued to the respondents calling for their response. The respondents submitted their response stating that no FIR copy was supplied to them relating to the alleged theft of the DTR of the complainant and unless the copy of the FIR is submitted to them, as per rules they cannot supply another DTR.
- **03.** Heard the Complainant and respondents through video conferencing.
- 04. Admittedly, the alleged theft of the DTR of the complainant was taken place about six years back. According to the complainant, FIR was registered in the police station concerned but according to the respondents, they were not supplied with any FIR copy. Hence, the complainant is directed to pursue the matter in the police station concerned, obtain a copy of the FIR and submit the same to the respondents on which the respondents shall initiate action as per rules in vogue. With the said direction, the complaint is closed. There is no order as to costs.
- **05.** The complainant is informed that if he is aggrieved by the order of the Forum, he may approach the Vidyut Ombudsman, 3rd Floor, Plot. No.38, Adjacent to Kesineni Admin Office, Sriramachandra Nagar,

Mahanadu Road, Vijayawada-08 in terms of Clause.13 of Regulation.No.3 of 2016 of Hon'ble APERC within 30 days from the date of receipt of this order and the prescribed format is available in the website vidyutombudsman.ap.gov.in.
