3) After careful consideration, APSPCDL accords approval for payment of Cost of Living Allowance payable to the Shift Operators working at 33/11 KV Sub-Stations w.e.f. 01.10.2012 @ Rs.665/- per month in addition to the Basic Wages of Rs.8,079/- per month.
