Re: In the matter of allocating inflated demand by the Andhra Pradesh Gas Power Corporation Ltd (APGPCL) to its shareholders.

**PUBLIC NOTICE**

The erstwhile Commission noticed that APGPCL has been allocating inflated demand (notional demand, i.e., Peak Demand generated in a 15 minutes time block in a month, against the actual average demand available on the bars during a month) to its shareholders and such allocation of notional demand to its shareholders is against the provisions of Memorandum of Understanding (MoU) entered between APTRANSCO / APDISCOMs and other large industrial consumers (having equity participation in APGPCL). Therefore, the erstwhile Commission ordered APTRANSCO / APDISCOMs to recover inflated demand charges raised and collected by APGPCL from APGPCL, vide Lr. No. APERC/E-205/DD-Dist/2010 dated 06-05-2010.

2. Aggrieved by the communication dated 06-05-2010, several petitions have been filed and Hon'ble High Court of Judicature at Hyderabad for the State of Telangana and the State of Andhra Pradesh was pleased to set aside the impugned communication dated 06-05-2010 on sole ground of not affording opportunity to the petitioners before a decision is taken and remanded the matter to the Commission for consideration afresh.

3. TAKE NOTICE THAT the above mentioned issue relating to allocation of inflated demand by APGPCL to its shareholders is mentioned in detail in Annexure appended to this notice. The Commission invites suggestions/views /objections of interested persons / stakeholders in respect of the subject matter of the issue mentioned in Annexure, appended to this public notice. TAKE FURTHER NOTICE that the subject matter of the petition will be taken up for public hearing by the Commission on 02-07-2016 at 11.00 AM in its Court Hall at Hyderabad and any interested persons /stakeholders / organization desirous of being heard in person, may appear before the Commission on the said date of hearing.
