ORDER :

The Andhra Pradesh Electricity Regulatory Commission formulated the fresh Regulation No.3 of 2016 for establishment and functioning of the Consumer Grievance Redressal Forum, the Vidyut Ombudsman and Consumer Assistance and for all matters. The same was published in Andhra Pradesh Gazette Part-I Extraordinary on 16.02.2016 which came into force from 01.03.2016.

2. As per the guidelines specified in the Gazette, a notification was issued on 01.04.2016 inviting applications for filling up of the post of Chairperson for Consumer Grievance Redressal Forum in terms of Regulation 5.2(a) and (b) in Southern Power Distribution Company of A.P.Limited from eligible persons.

3. After careful consideration of the applications received and as per the minutes of the selection committee held on 01.09.2016, the APSPDCL hereby accords approval for appointment of **Sri. A.Jagadeesh Chandra Rao as Chairperson for Consumer Grievance Redressal Forum for a term of three (3) years from the date he enters upon his office in Southern Power Distribution Company of Andhra Pradesh Limited**

4. He will receive an honorarium of Rs.60000/-(Rupees Sixty thousand only) per month during the first year of service. Such monthly honorarium will be increased by Rs.2500/-(Rupees Two thousand five hundred only) for each year of service completed in such office.

5. He will receive a house rent allowance of Rs.15000/- (Rupees Fifteen thousand only) per month.

6. He and his family will be entitled to the same benefits of medical attendance and medical treatment to which a Chief Engineer/Chief General Manager of the APSPDCL is entitled.

7. He will be eligible per annum for casual leave of fifteen (15) days, Optional holidays for five(5) days and Extra-ordinary leave on loss of pay for such period as the competent authority may consider just and reasonable. The Chairman & Managing Director of the APSPDCL is the competent authority to sanction such leave to the Chairperson.

8. He will be entitled for travelling allowance and daily allowance for journeys for participation in the forums proceedings as are admissible for official tours to a Chief Engineer/Chief General Manager of the APSPDCL.

9. The other terms and conditions specified by the Andhra Pradesh Electricity Regulatory Commission in Regulation No.3 of 2016 which was published in the Gazette Part-I Extraordinary on 16.02.2016 and came into force with effect from 01.03.2016 will be applicable.

10. Sri. A.Jagadeesh Chandra Rao shall report to the Chairman and Managing Director, APSPDCL on or before **20.09.2016** failing which this order stands cancelled without any further correspondence.
