As per the retirement notices issued, certain employees mentioned in the Annexure (enclosed) have retired from service on attaining the age of superannuation of 58 years on the dates mentioned against their names.

2. In the S.O.O. 10<sup>th</sup> read with S.O.O 11<sup>th</sup> cited, it has been ordered that the age of retirement on superannuation of an employee of the APSPDCL is the date on which he/she attains the age of 60 years. These orders shall come into force with retrospective effect from 02.06.2014. Further in the memo 12<sup>th</sup> cited instructions have been issued to effect re-induction of retired employees consequent to issuance of the aforesaid S.O.Os 10<sup>th</sup> & 11<sup>th</sup> cited.

3. In pursuance of these orders issued in the S.O.O. 10<sup>th</sup> read with S.O.O. 11<sup>th</sup> cited, they are eligible for re-induction into service as they have not attained the age of superannuation of 60 years, provided that they remit back the pensionary benefits (viz. (a) Commuted value of pension, (b) Retirement Gratuity (c) Encashment of Earn Leave), along with interest thereon in terms of orders issued vide memo 12<sup>th</sup> cited.

4. Therefore, they are requested to remit the amounts (inclusive of interest upto **31.08.2017**) on or before **30.09.2017** by way of DD/Cheque/On line transfer to **A/c.No. 52089645509, (IFSC : SBIN0020328), SBI, Near Municipal Office, Tirupati** and the DD should be drawn in favour of **Pay Officer/ APSPDCL/Corporate Office/ Tirupati**. Retired employees (As per Annexure) who are drawing pension in other Units shall remit the amounts as per Memo 12<sup>th</sup> cited in favour of their Pension Drawing Officers/Accounts Officers/ Expenditure of the concerned Circles so as to enable this office for issue of re-induction orders. Further interest per day shall be levied towards the said pensionary benefits, till date of remittance.

5. The Retired employees as per annexure may produce the NDC/ Clearance Certificate from the concerned Drawing officers for obtaining re-induction orders.

6. Re-induction orders will be issued after **30.09.2017** only. However, the period from the date of remittance to the date of issue of re-induction orders will be treated as compulsory wait.
