- 5. All the Heads of Department/Pay Drawing Officers of APSPDCL are requested to take necessary action accordingly.
- 6. "The contribution towards EPF shall be paid only on basic wage of the outsourced workers limited to Rs.15,000/- excluding other allowances".
- 7. It is further directed to implement these orders with effect from February/2024.
