Sub:- APSPDCL – TPT – Scheme for voluntary disclosure of additional loads by domestic consumers (Cat-I) for the period from 01.03.2025 to 30.06.2025 - Regularization of additional load on payment of 50% of Development charges and corresponding full Security Deposits by the consumers - Reg.

In the reference (1) cited above, It is to inform that Hon'ble APERC has introduced the Scheme for voluntary disclosure of additional loads by domestic consumer (Cat-I) for the period from 01.03.2025 to 30.06.2025 for regularization of additional load duly collecting of 50% of Development charges and corresponding Security Deposit in full to the additional loads as per **regulation No.6 of 2004**.

"Voluntary Disclosure of Additional Loads by Domestic Consumers for Regularization" says that: -

- 1. Under the scheme interested/willing existing domestic consumers may voluntarily declare their additional loads to the Discoms over and above the connected load shown in the CC Bills. As directed in RST Orders of FY 2022-23 an exclusive window on the DISCOMs website will be created for the hassle-free regularization of additional loads. The DISCOMs may also inform the consumers of additional load based on the data recorded in meters.
- 2. After receipt of Domestic consumers voluntary declaration of additional loads, DISCOMs shall regularize the same, collecting 50% of Development charges as approved by the Commission in Regulation No.6 of 2021.
- 3. The Security Deposit in full corresponding to additional loads must also be collected as per regulation No.6 of 2004 and its amendments.
- 4. The scheme's operation period is from 01.03.2025 to 30.06.2025. This one-time opportunity for consumers will not be extended after 30.06.2025.

In this regard, all the Superintending Engineers/Operation/ are requested to give wide publicity to the above **mentioned voluntary scheme** and conduct mass awareness programme by sending SMS to register mobile numbers, printing posters and displaying the same at all offices from the District level Offices to section/Sub-Station level, Gram Ward, Sachivalayams, advertisements/ public

notifications in the print and electronic media, messages in local cable network and FM Radio to reach the message to all corners of the domestic sector **and release** the additional loads within time frame and submit the monthly progress to this office by 1<sup>st</sup> week of every month.

The General Manager/IT & SAP/APSPDCL/Tirupati is requested to make arrangement in APSPDCL Website to register and make payment for additional loads by the domestic consumers under this **voluntary scheme** and provide dash board for getting information on No. of applications registered and additional loads released for onward submission to the Hon'ble Commission.
