**ABSTRACT**

APSPDCL - HRD - Restructuring of Districts in Andhra Pradesh - Formation of 4 (Four) New Operation Circles in the newly formed 4 (Four) Districts in the jurisdiction of APSPDCL duly diverting the existing sanctioned posts (Man power) of Corporate Office/APSPDCL & Other posts of Operation Circles in APSPDCL for operational and administrative convenience and for better consumer services - Orders - Issued.

**ORDER:**

In the reference 1<sup>st</sup> cited, the Government of Andhra Pradesh have issued orders duly forming new districts in Andhra Pradesh.

- 2) As of now 5 Nos. Operation Circles for each District (before the formation of new Districts) are existing in the jurisdiction of APSPDCL. The details are as follows:

- 3) After formation of the new districts in the state, the existing jurisdiction of APSPDCL is spread over the following 9 Districts as detailed below:

4) Therefore, to meet the Operational and administrative exigencies and implement the Government policies, initiatives, and programs pertaining to the above Districts concerned, it is felt necessary to create new Operation Circles for the newly formed Districts within the jurisdiction of the APSPDCL.

5) Accordingly the approval of Govt. of A.P. was received vide reference 3<sup>rd</sup> cited, for creating new Operation Circles. The following Operation Circles are created and some organizational changes are made to the MRT Divisions in the newly formed Districts coming under the jurisdiction of APSPDCL as detailed hereunder and as appended in the Annexure, duly diverting and allocating the existing sanctioned posts of Corporate Office/APSPDCL & Other posts of Operation Circles in APSPDCL without any additional financial burden on APSPDCL.

6) The restructuring of Operation Circles and Divisions inter-alia necessitates the inter-se allocation of existing posts & personnel to the re-organized Operation Circles and Divisions. Accordingly, 4 New Operation Circles and 4 new MRT Divisions are formed duly bifurcating the existing Operation Circles and existing Transformers and M&P Divisions by diverting and allocating the existing sanctioned posts of Corporate Office/APSPDCL & other posts of Operation Circles as appended to this Order in the Annexure. The Quality Control, District Stores are continued as they are, and the jurisdiction also remains the same as earlier. The DPE Circle is also re-organised and allotted personnel to newly formed 4 circles.

7) In view of the posting of Deputy General Manager to discharge the duties of SAO's in certain Circles, the existing delegation of powers shall stand modified accordingly. Similarly, the delegation of powers shall also stand modified with respect to the designations that were now revised. Further, the Deputy General Managers who are posted to the Operation Circles are directly placed under the control of the Superintending Engineer/ Operation, and they shall report to the Superintending Engineer/ Operation concerned with regard to Service Matters and SAP HCM of the entire Circle.

8) The lien and seniority of the personnel up to the cadre of Junior Accounts Officer in Accounts Services, Jr. Engineer in Engineering Services, Office Sub-Ordinates in General Services and O&M posts (SLI and FM) shall be maintained at the Parent Circle until further orders. Further, the lien and seniority of the personnel in existing Transformers and M&P divisions shall be maintained at the Parent Divisions only. The Chief General Manager/Operation shall act as nodal officer and Superintending Engineers of parent and new circles shall re-organise the Personnel as per the organogram (annexed) and fix the jurisdiction of each Section/Sub-Division/Division under the Circles. The Chief General Manager/Operation & the Superintending Engineers/Operation concerned are requested to follow the guidelines scrupulously.

9) The Chief General Managers and Superintending Engineers/Operation are requested to take necessary action accordingly.

10) These orders are issued with the concurrence of Director (Finance) Dt.25.09.2024.

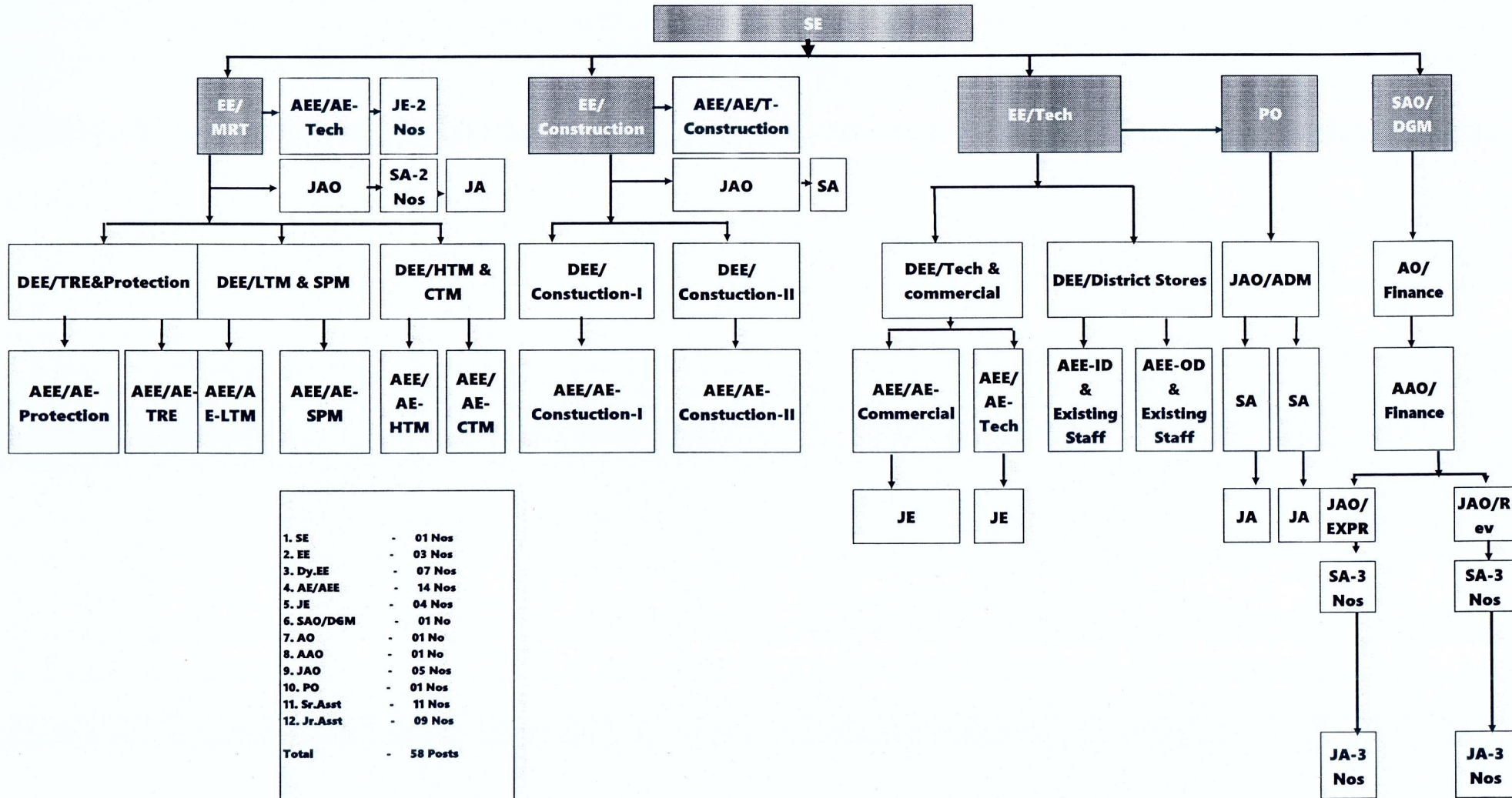

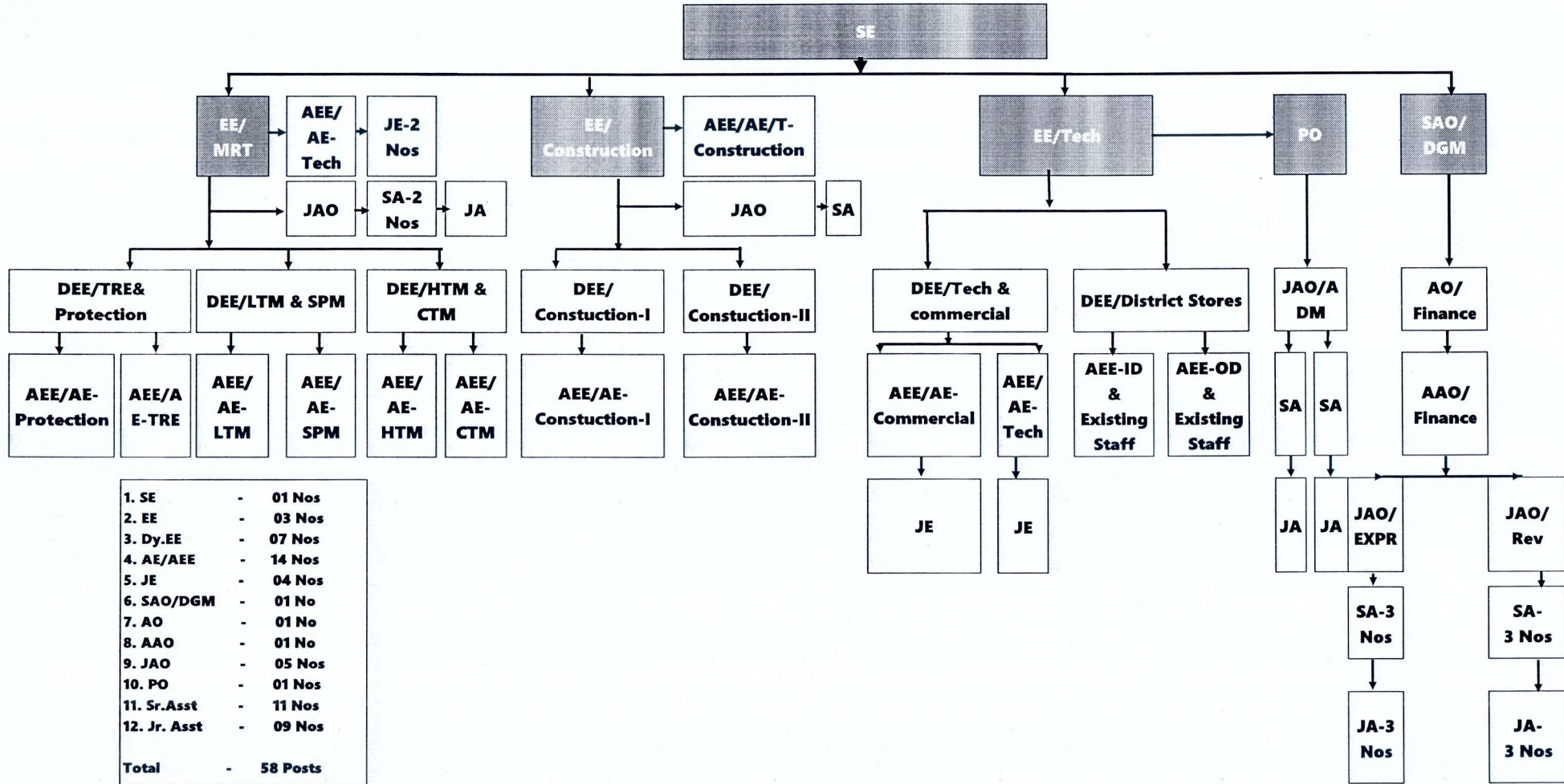

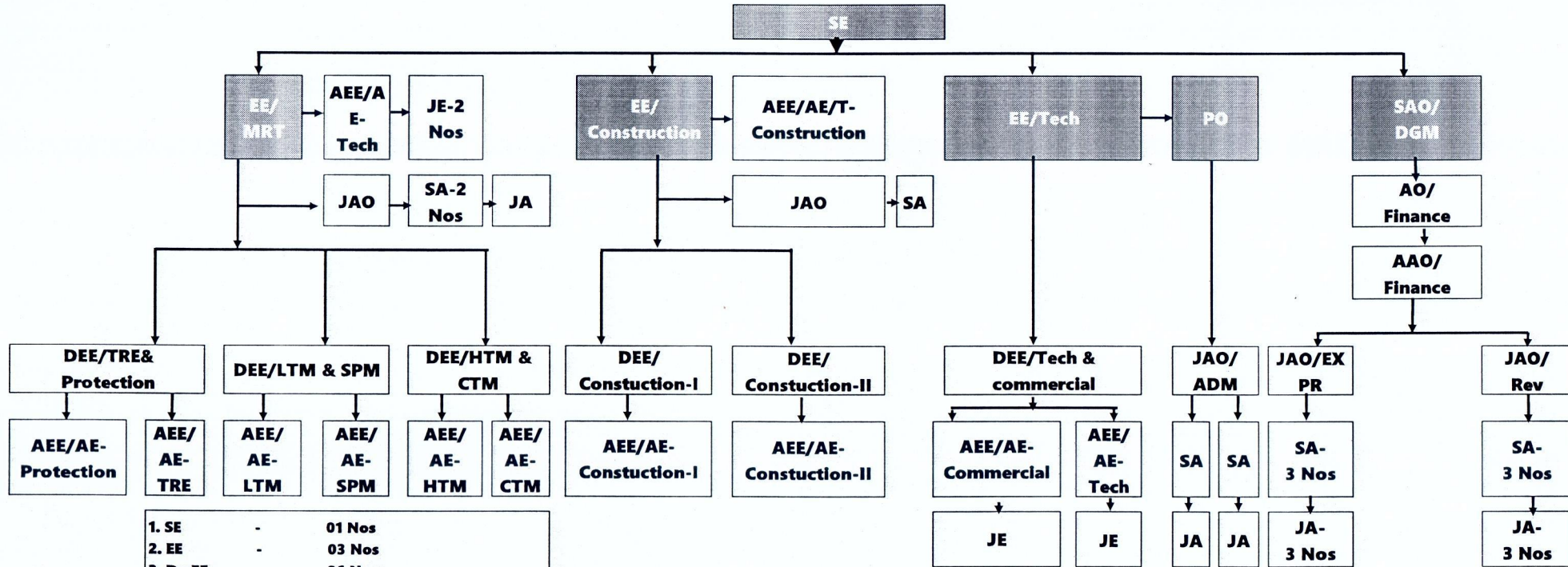

**ORGANOGRAM OF OPERATION CIRCLE :: CHITTOOR**



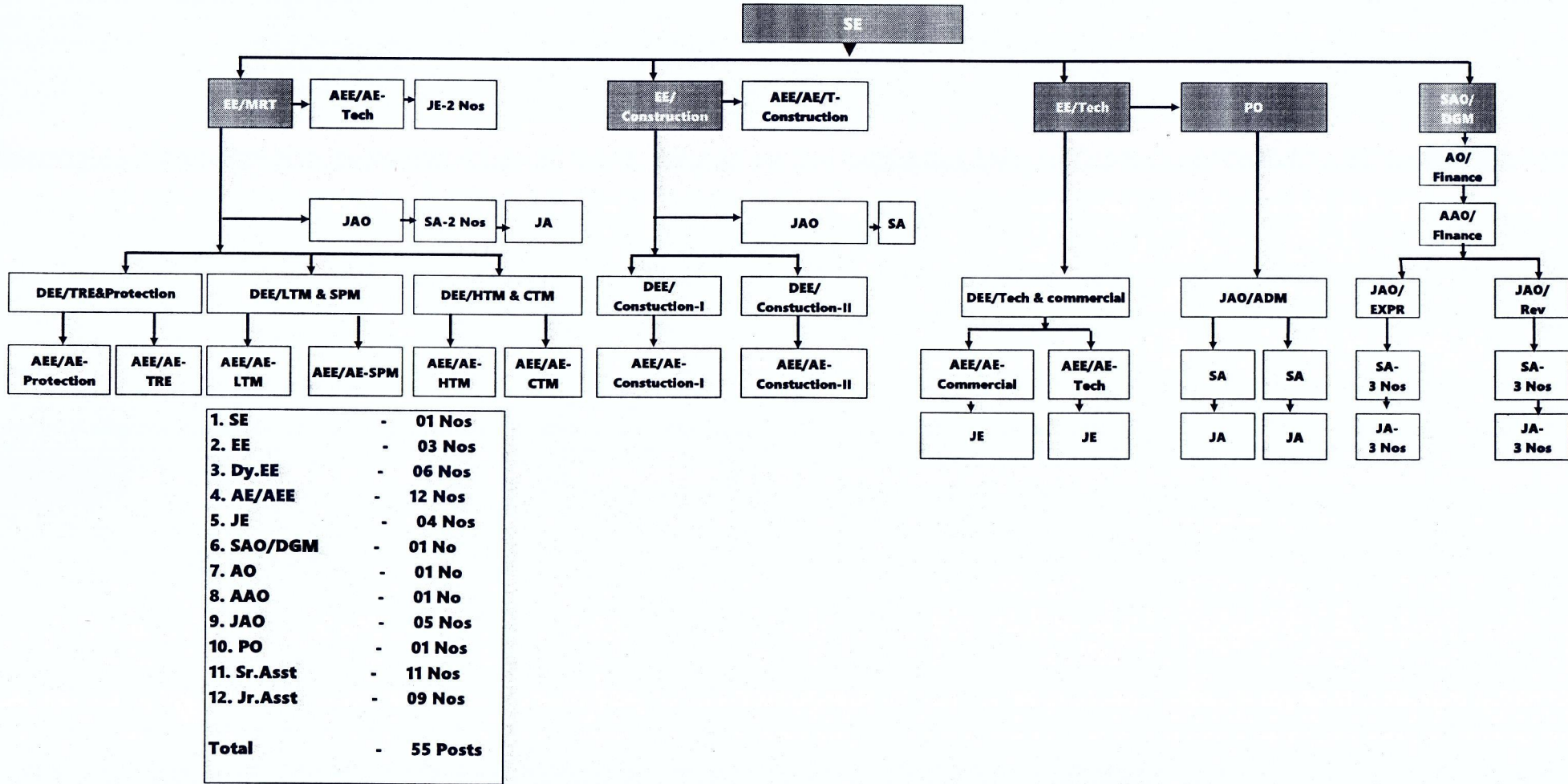

**ORGANOGRAM OF OPERATION CIRCLE :: ANNAMAIAH AT RAYACHOTY**



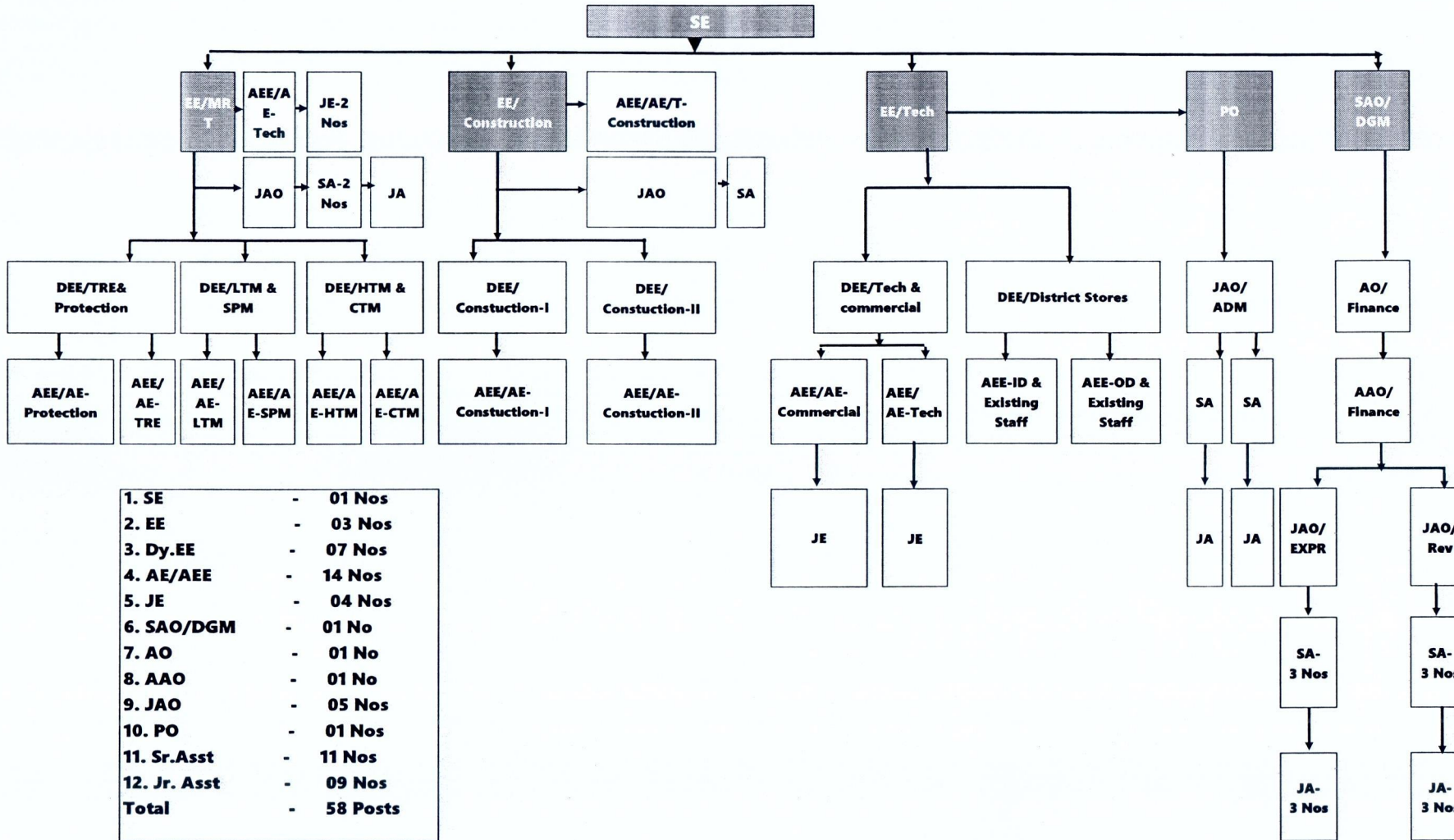

AFTER RE-STRUCTURING**



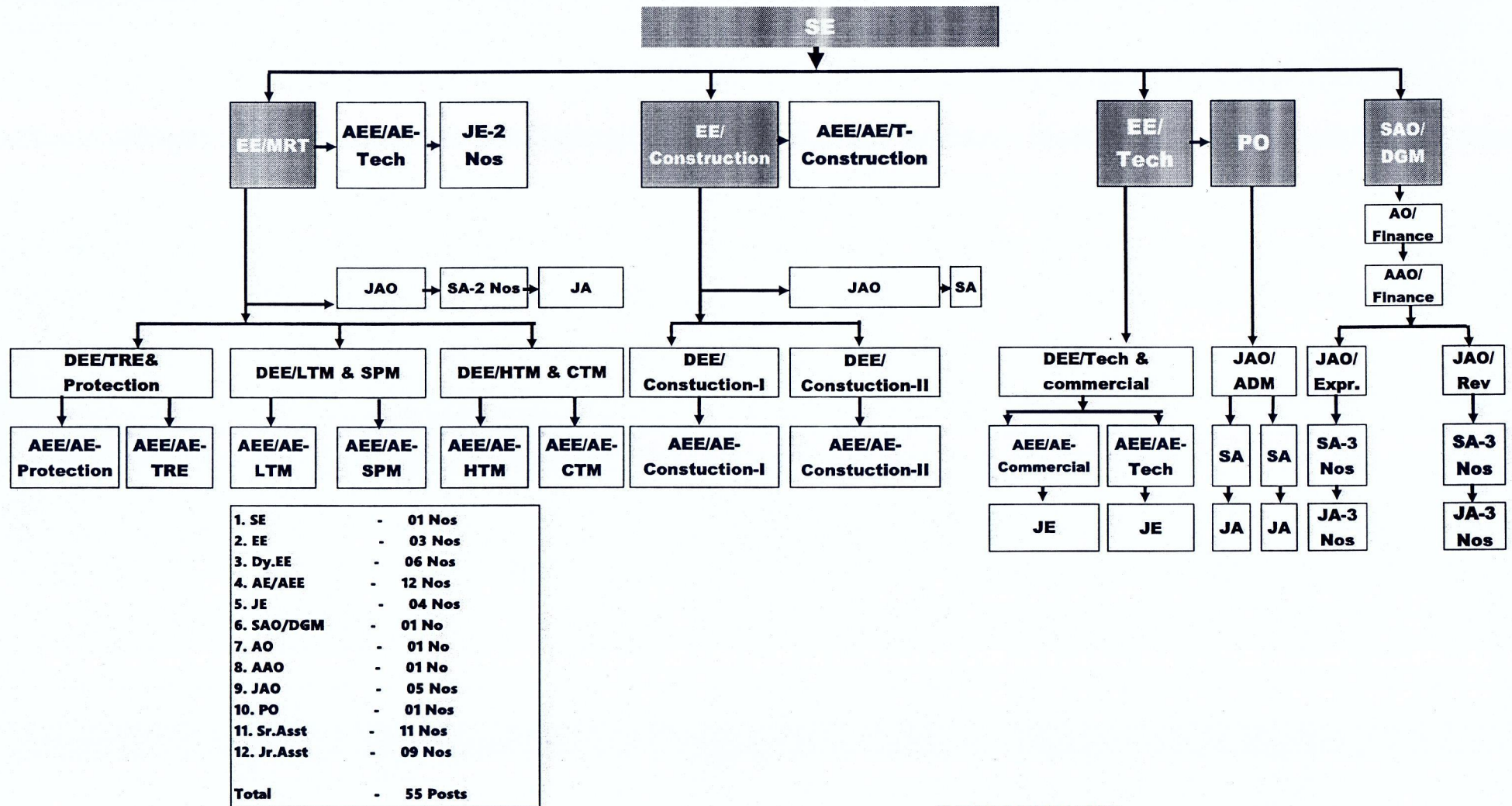

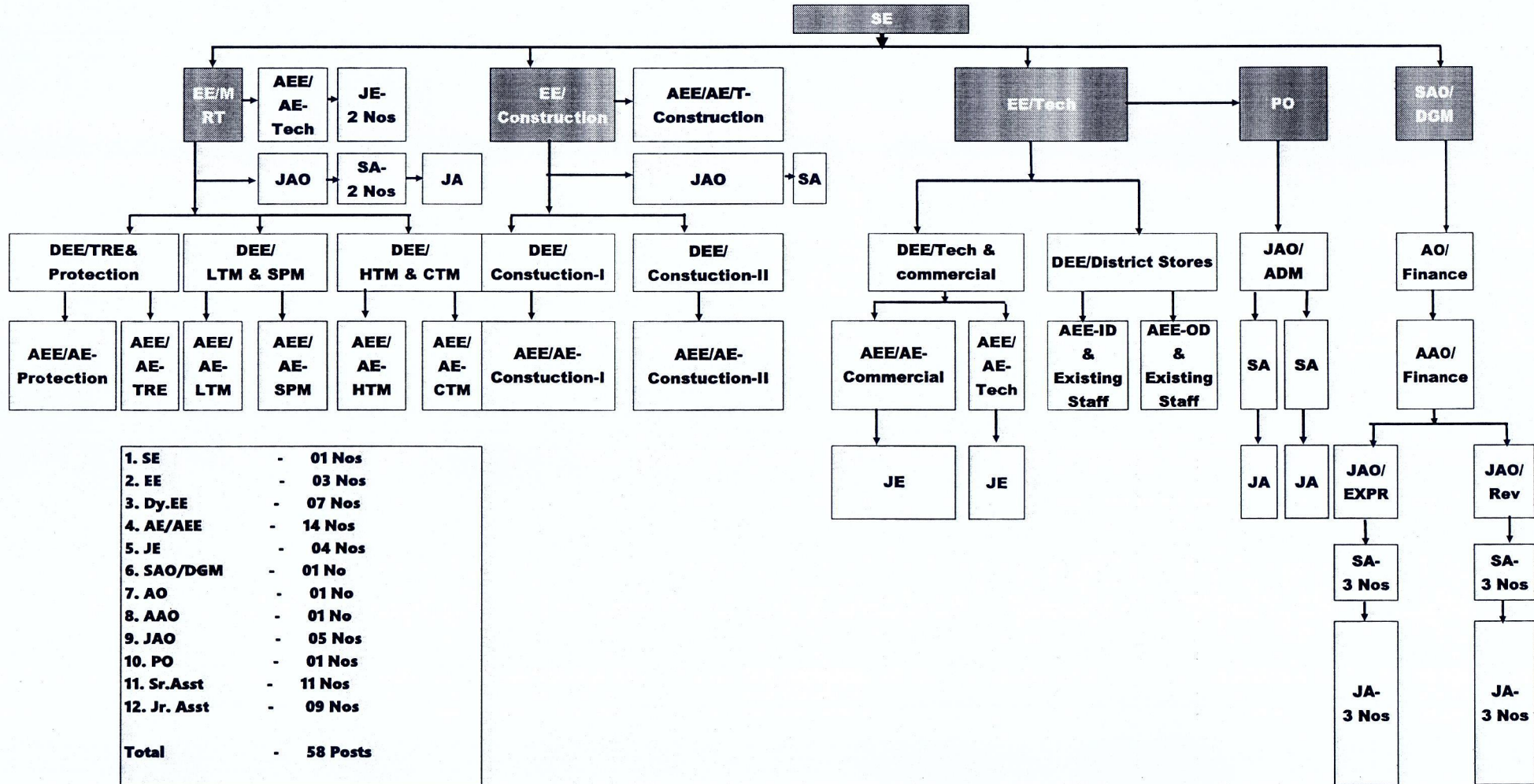

AFTER RE-STRUCTURING**

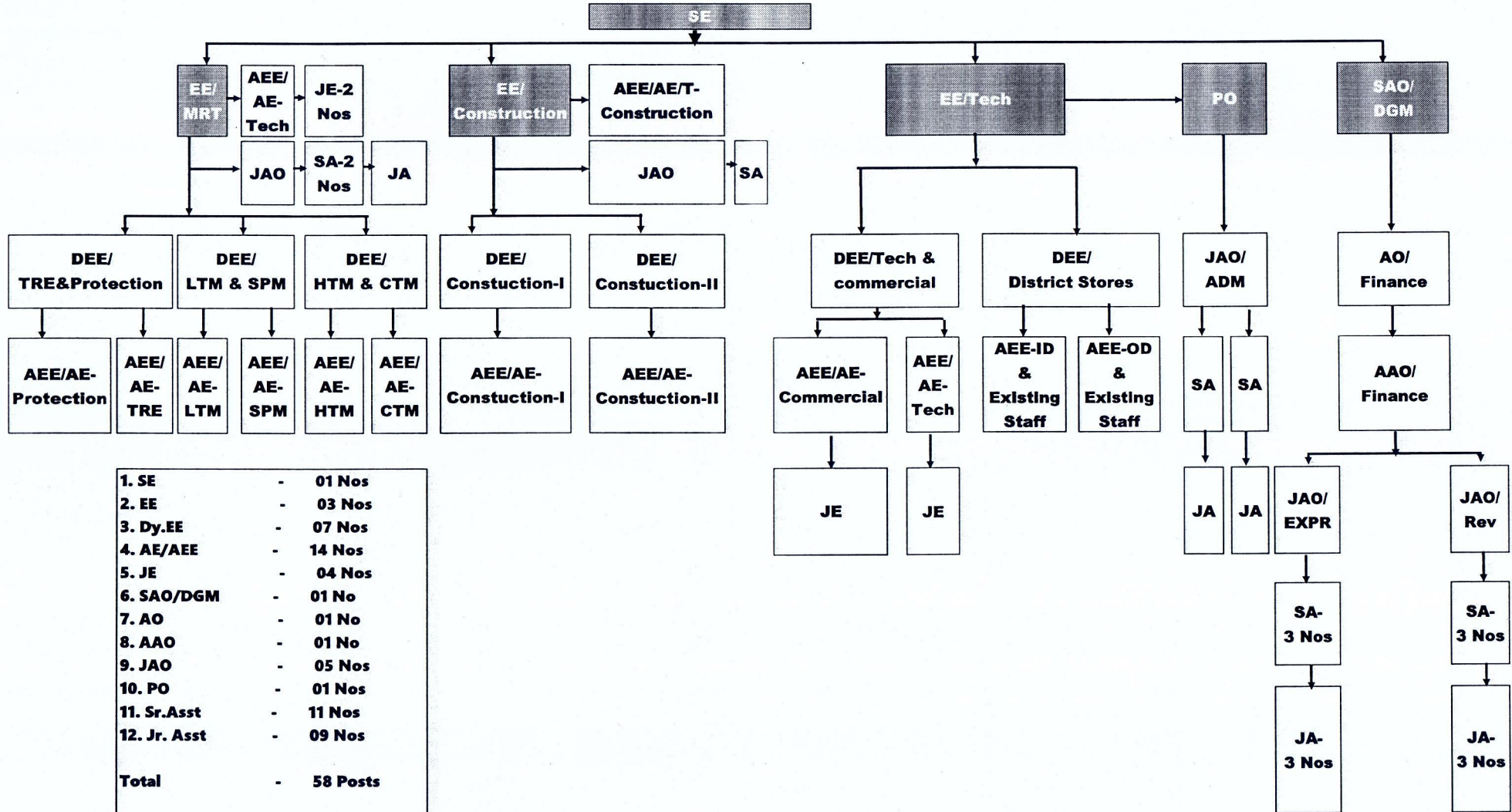

AFTER RE-STRUCTURING**



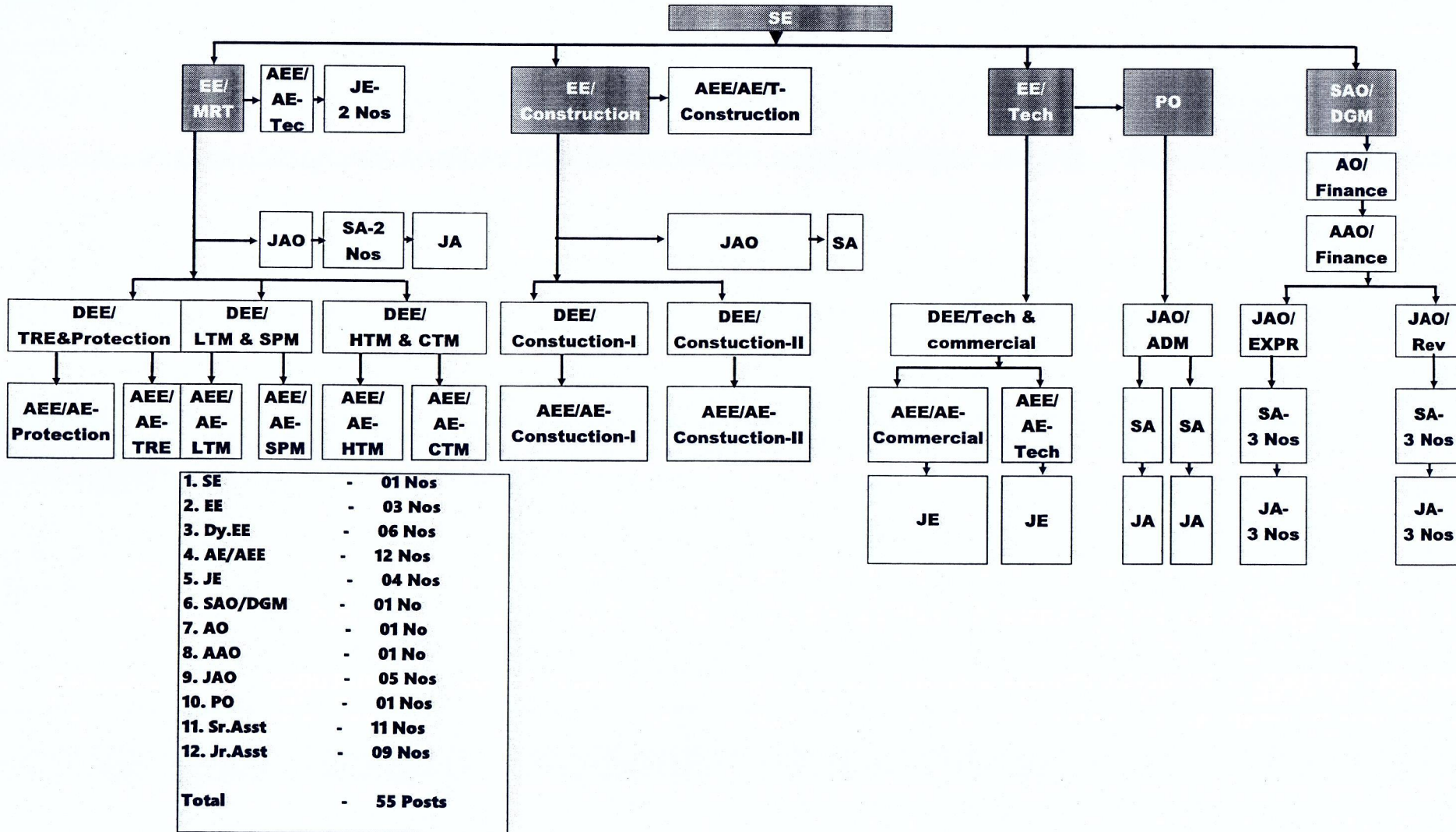

**ORGANOGRAM OF OPERATION CIRCLE :: SATYASAI AT PUTTAPARTHI**



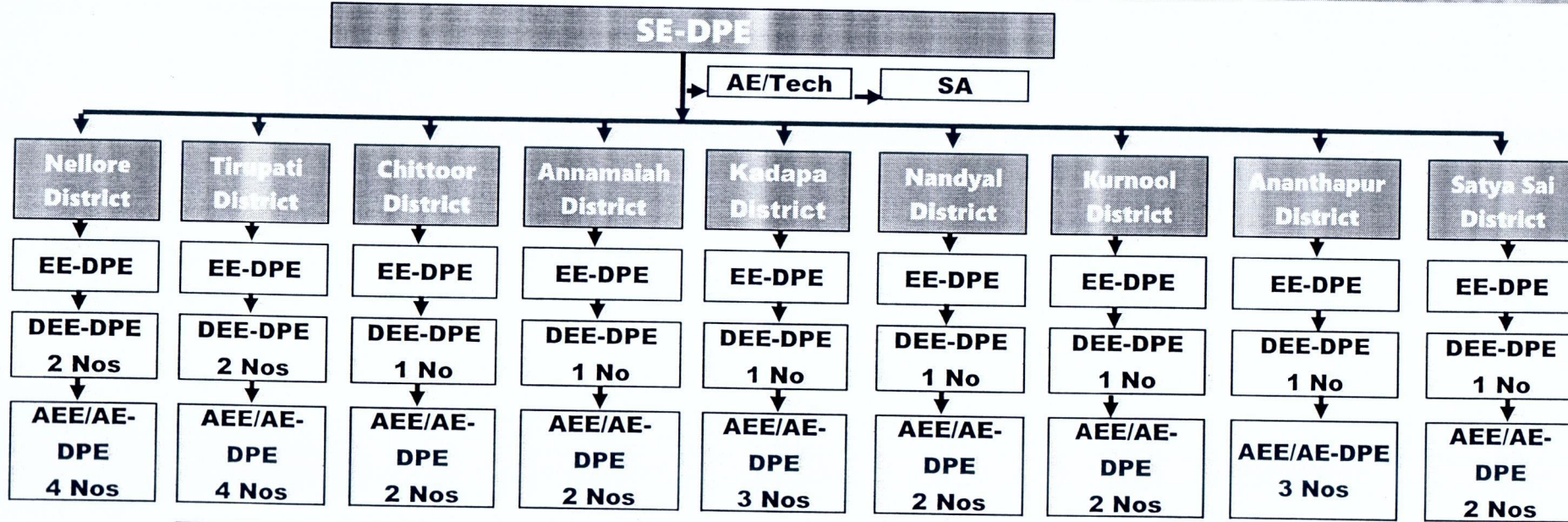
