In the reference 1<sup>st</sup> read above, Government of Andhra Pradesh Finance Department, instructed not to deduct the commutation portion of pension from all the pensioners who have completed 11 years 3 months from the date of commencement of commutation recovery, until further orders.

2. In the reference 2<sup>nd</sup> read above, Government of Andhra Pradesh, Directorate of Treasuries and Accounts, also issued instructions read with the instructions issued by Finance Department, Government of AP, to all Pension Disbursing Authorities and STOs. In these instructions, it was ordered not to recover / deduct commutation portion of pension from the basic pension in respect of all the AP Pensioners, who have completed 11 years 3 months as on 31.10.2024 from the date of commencement of commutation, until further orders.

3. Recently, some of the retired employees of APTRANSCO and other Power Utilities who are drawing pension from respective power utilities have also filed Writ Petition No.26766/2024, WP.No. 28272/2024 and batch including WPs filed by Government employees, seeking relief with similar prayer. In W.P. No. 28272/2024 and batch, Hon'ble High court passed interim orders that "Notice.

Service is waived by learned Additional Advocate General on behalf of the respondents.

Response be filed.

List on 10.12.2024 along with W.P.No.24822 of 2024.

In the meantime, no recovery be effected from the pension of the petitioners."

4. After careful examination, all the Pension disbursing authorities of APTRANSCO are hereby instructed not to recover/ deduct commutation portion of pension from the basic pension in respect of all the pensioners of APTRANSCO who have completed 11 years 3 months as on 31.10.2024 from the date of commencement of commutation, until further orders. Further, it is also instructed that, in case of the petitioners in W.P.No.28272/ 2024 and batch (WPs annexed to this orders), deduction of commuted portion of pension shall be done as per the interim orders of Hon'ble High Court of Andhra Pradesh at Amaravathi in Wp.No.28272 of 2024 and batch.

It is submitted that vide reference 1<sup>st</sup> cited, the learned AAG has instructed this department issue direction to the concerned not to deduct the commutation amount from the pensioners who have completed 11 years 3 months from the date of sanction of commutation until the final orders of the Hon'ble Court, in view of the various cases that are being filed daily by the retired pensioners.

4. Accordingly, this dependent has issued a Memo vide reference 2<sup>nd</sup> cited, by directing the Director of Treasuries & Accounts that **not to deduct the commutation portion of pension** from all the pensioners who have completed 11 years 3 months, till further orders.

5. In view of the above position, the Additional Advocate General is requested to apprise the Hon'ble Court in this regard and seek four (4) weeks to file detailed counter in the matter.
